#### Rising injuries among older male motorcyclists: study

# Are Ontario highways in the slow lane? Some argue higher speed limits would lead to safer roads October 11, 2014, Brant News (BRANTFORD, ONTARIO)

Chris Klimek believes there is growing consensus in North America that driving faster on major highways is actually safer and can reduce the number of motor-vehicle accidents that take place. "There is much misconception about driving fast and driving safe," said Klimek, founder of Stop100, an advocacy group that has been working to raise Ontario highway speed limits from 100 km per hour to 120 km per hour and 130 km per hour in express lanes.

### Transport Ministry permanently cuts ties with Canada border agency

The controversial practice of using commercial roadside vehicle blitzes to round up undocumented workers is over.

Transportation Minister Steven Del Duca said Friday that partnering with the Canada Border Services Agency doesn't make sense, as he officially cut ties with the organization in light of a controversial roundup of undocumented workers in August that sparked an internal ministry review...

... "The review found that the partnership with the Canada Border Services Agency did not align with our mandate" of road safety, stated Del Duca.

#### Tractor-trailer drivers not tested on highways at Ontario's busiest test centre

October 10, 2014, Toronto Star (TORONTO, ONTARIO)

Tractor-trailer drivers are earning their licences at Ontario's busiest truck testing centre without being taken on a major expressway, a Star investigation has found.

While car drivers travel on highways during their road tests, the Ministry of Transportation — which oversees all vehicle licensing in the province — allows tractor-trailer candidates to avoid being tested on highways with high speeds and merge lanes, where most trucking takes place.

#### Access gates in moose fencing

October 10, 2014, Government of New Brunswick (FREDERICTON, N.B.)

The Department of Transportation and Infrastructure continues to receive reports of access gates in wildlife fencing being left open.

Leaving these gates open puts the travelling public at higher risk of being involved in a moose collision. The integrity of wildlife fencing is critical to highway safety.

#### Anti-drunk driving group supports Iqaluit beer wine store October 9, 2014, CBC News (IQALUIT, NUNUVIT)

Mothers Against Drunk Driving is weighing in on whether the Nunavut government should open a pilot beer and wine store in the capital.

The territorial government has put forward the idea as a harm reduction approach, arguing that a direct-sales model would help curb bootlegging and binge-drinking, because the store would only sell beer and wine — not hard liquor.

# Group uses 'geofencing' to warn against walking and texting

The dangers of texting while driving are well known, but a B.C. safety organization is taking new steps to get people to think twice before texting while walking.

This fall, Preventable BC has been using "geofencing" technology to send pedestrians at certain busy intersections in Vancouver and Victoria a reminder of the dangers of texting while walking.

When people with geo-enabled mobile devices cross the virtual boundary set up at these intersections, they will receive this message from Preventable: "If you're texting while walking, have a word with yourself."

#### Texting while driving: That'll cost you

October 9, 2014, Montreal Gazette (MONTREAL, QUEBEC)

Demerit points for cellphone use while driving in Quebec will go from three points to four as soon as next spring, possibly by February.

If the rules change, Quebec will be one of three provinces to assign four demerits, the harshest in the country.

### B.C. takes first step in renewed fight against distracted driving

October 8, 2014, Government of B.C. (VICTORIA, B.C.)

The Province is taking a first step in what will be a two-part approach to protect British Columbians from distracted drivers on roads and highways.

First, effective Oct. 20, 2014, amendments to the Motor Vehicle Act (MVA) regulations will increase the driver penalty points from zero to three for drivers who are caught talking on a handheld device while driving. This new penalty, which also covers infractions like watching a DVD, programming a phone's GPS, and operating hand-held audio players, is being combined with the \$167 fine already in place and is now consistent with the three points and \$167 fine currently given to drivers for texting.

#### Talking cars actually more dangerous, studies find

Two new studies have found that voice-activated smartphones and dashboard infotainment systems may be making the distracted-driving problem worse instead of better.

The systems let drivers do things like tune the radio, send a text message, or make a phone call while keeping their eyes on the road and their hands on the wheel, but many of these systems are so error-prone or complex that they require more concentration from drivers rather than less, according to studies released Tuesday by the AAA Foundation for Traffic Safety and the University of Utah.

### More than 160 road deaths attributed to Big Four this year says OPP

The "Big Four" were contributing factors in 168 of the 216 road deaths investigated by the OPP this year (2014). The "Big Four" refers to the four main causal factors in motor vehicle collision deaths: distracted driving, speeding, impaired driving and lack of occupant restraint. These four factors are the leading causes of collision deaths throughout Canada.

For this reason, the OPP will be joining policing partners across the country for Operation Impact - a national road safety enforcement and education campaign endorsed by the Canadian Association of Chiefs of Police (CACP).

# 2014 Campaign - "Pedestrians aren't protected like cars, and have no chance against one"

October 7, 2014, SAAQ (QUEBEC, QUEBEC)

The SAAQ is launching an awareness campaign to improve the safety of pedestrians at intersections. It is aimed at pedestrians and drivers, both of whom need to change their habits. The campaign focuses on intersections because 55% of pedestrians killed or injured in 2013 were involved in an accident at an intersection.

The campaign includes a TV commercial, a radio ad, a publicity stunt and a Web message.

#### Can I get the other driver's cellphone records to determine fault in an accident?

My wife was involved in a motor vehicle collision - she was in the centre lane and had a vehicle cross over the lane markings and side swipe her from the left. Our insurance has still not come to the determination that the accident was no fault of my wife, as she was hit from her rear bumper and up the left side of her vehicle, up to the middle of her driver side door. Is it possible to obtain the cellphone records of the other motorist to confirm or discount distracted driving as the cause of the accident - that is, the other driver texting/e-mailing while driving? - Ilija

# Canada's transportation ministers approve changes to trucking regulations and the National Safety Code

October 3, 2014, Government of Yukon (WHITEHORSE, YUKON)

Federal, provincial and territorial Ministers of Transportation and Highway Safety endorsed changes to regulations for commercial heavy trucks, as well as updates to the National Safety Code (NSC), at the conclusion of the Transportation Association of Canada annual conference in Montreal, Quebec on October 1.

"The continued harmonization and standardizing of regulations across Canada will make shipping to and from Yukon more efficient," Minister of Highways and Public Works Wade Istchenko said. "The changes to the National Safety Code will improve the safety of drivers and support an ongoing commitment to ensuring that Canada and Yukon roads are among the safest in the world."

#### Legacy of 4-year-old killed by drunk driver continues

The legacy of Alexa Middelaer continues with a new bus to fight against drinking and driving.

Four-year-old Alexa was with her aunt feeding a horse on the side of the road when she was struck and killed in May of 2008. Carol Berner, who was over the legal limit, was also 40 km over the speed limit and lost control, hitting both Alexa and her aunt by a Delta ranch. Berner was sentenced to 30 months in prison in 2010.

### MP asks government to change law on blood-alcohol samples

October 2, 2014, Ottawa Citizen (OTTAWA, ONTARIO)

Justice Minister Peter MacKay is mulling a request to extend the period during which police can obtain warrants for blood-alcohol samples from impaired drivers after accidents.

Potentially impaired drivers who are injured in a crash are often sent to hospital before police start investigating. In these cases, Criminal Code section 256 currently allows police four hours to get a warrant to for a blood sample if a physician believes the driver is unable to consent.

#### Distracted drivers to face more demerits in B.C.

The B.C. government plans to roll out new sanctions against distracted driving in the next three months, but they are unlikely to include stiffer fines, says Attorney General Suzanne Anton.

A senior Victoria police officer has called for fines that are higher than the \$167 introduced on Feb. 1, 2010, but Anton said that is not being considered.

#### Nova Scotia texting-while-driving penalties increasing October 1, 2014, CBC News (HALIFAX, NOVA SCOTIA)

Nova Scotia will soon increase fines and penalties for texting while driving.

After Feb. 1, the new fines will be:

\$233.95 for a first offence (rising from \$176.45). \$578.95 for a third or subsequent offence (up from \$348.95). Four demerit points added upon conviction.

# Insurance survey shows Canadians still driving using smartphones despite fines

Allstate Insurance recently conducted a national survey of more than 1200 drivers. This Canada Distracted Driver Poll revealed some very disturbing statistics.
